### Disclosure regarding Higher Education Emergency Relief Fund Emergency Financial Aid Grants to Students

The Coronavirus Response and Relief Supplemental Appropriations Act, 2021 ("CRRSAA"), Pub. L. No. 116-260 (December 27, 2020) and the American Rescue Plan Act of 2021 ("ARP"), Pub. L. No. 117-2 (March 11, 2021), provided relief to institutions and students for costs associated with the coronavirus emergency. The coronavirus emergency is defined in Proclamation 9994 of March 13, 2020, "Declaring a National Emergency Concerning the Novel Coronavirus Disease (COVID-19) Outbreak," Federal Register Vol. 85, No. 53 at 15337-38.

Under both CRRSAA and ARP, the U.S. Department of Education ("ED") has allocated funds to Florida National University (OPEID 025476) to be used to "provide financial aid grants to students (including students exclusively enrolled in distance education), which may be used for any component of the student's cost of attendance or for emergency costs that arise due to coronavirus, such as tuition, food, housing, health care (including mental health care), or child care." See CRRSAA § 314(c)(3); ARP § 2003.

In accordance with the Department's May 13, 2021, Federal Register Notice, the University provides the following information.

- 1. The University acknowledges that it signed and returned to the Department the applicable Certification and Agreement and assures that it has used, or intends to use, all funds allocated to it under CRRSAA and ARP to provide Emergency Financial Aid Grants to students.
- 2. Florida National University's Allocation:
  - 1. Total CRRSAA allocation: \$4,055,230, which will be used only for student Emergency Financial Aid Grants.
  - 2. Total ARP allocation: \$2,451,026, which will be used only for student Emergency Financial Aid Grants.
- 3. The total amount of Emergency Financial Aid Grants distributed to students under the CRRSAA and ARP programs during the period covered by this report: **\$4,097,100.00**
- 4. The estimated total number of students at the University eligible to receive Emergency Financial Aid Grants under the CRRSAA and ARP programs is **3,530**. All FNU students are eligible to receive emergency grants under the CRRSAA and ARP programs, including U.S. citizens, permanent residents, refugees, asylum seekers, Deferred Action for Childhood Arrival (DACA) recipients and similar undocumented students, and international students.
- 5. The total number of students who have received an Emergency Financial Aid Grant under the CRRSAA and ARP programs during the period covered by this report: **2,138**.
- 6. FNU is distributing Emergency Financial Aid Grants to eligible students (defined above) who are (1) enrolled at FNU in a term that begins before the COVID-19 national emergency declaration is terminated, (2) in a degree or certificate program or as a transient student, and (3) enrolled at the time grant awards are calculated.

FNU's process for distributing Emergency Financial Aid Grants prioritizes students with exceptional need. Grants are divided into three tiers of equal amounts, with students demonstrating greater need and meeting other criteria receiving a higher tiered amount as follows: (1) Tier 1: Domestic undergraduate regular (degree- or certificate-seeking) students with an "estimated family contribution" ("EFC") of \$0 (highest grant amount); (2) Tier 2: Domestic undergraduate regular students with an EFC that qualifies them to receive a Pell Grant; and (3) Tier 3: All other eligible recipients (including students for whom FNU does not have an EFC) (lowest grant amount). A student's EFC is determined based on their most recent FAFSA (ISIR) on file. FNU determined that awarding higher grant amounts to students with greater need (as reflected by EFC and resulting Pell eligibility) will "prioritize grants to students with exceptional need, such as students who receive Pell Grants," as required by CRRSAA. The process further prioritizes domestic undergraduate students, consistent with ED guidance. Domestic undergraduate regular students without a FAFSA on file may submit one by the deadline established by the University to have their level of need considered. Eligible students without a FAFSA (ISIR) on file by such deadline, and all international students, graduate students, and transient (non-degree or certificate-seeking) students, will be eligible for a Tier 3 grant.

Students must complete a Grant Election Form to be considered for a grant. FNU has emailed each potential recipient with a copy of the Grant Election Form and instructions for being considered, including information for eligible students who have not filed a FAFSA. Once selected for a grant, FNU will notify a student of the award amount and provide instructions regarding permitted uses of the funds. Students will be advised to return any Emergency Grant funds expected to exceed their relevant permitted expenses. Emergency Grants will be paid directly to students and are not conditioned on a student's continued or future enrollment.

Any funds remaining following the initial disbursement process, including any funds returned or not claimed by a student, will be allocated to other students with need or returned to ED. Subsequent rounds of Emergency Grants, if any, may be in different amounts and subject to different eligibility criteria.

### \*Information for Undergraduate Students who did not file a FAFSA\*

If you reside in the United States and are a degree/certificate-seeking undergraduate student, you may be eligible for a larger grant amount based on information in your Free Application for Federal Student Aid. If you did not file a FAFSA and would like to be considered for a larger grant amount based on your financial need, please submit a FAFSA now at https://fafsa.ed.gov/. The University must receive your FAFSA results by [Deadline] for your need to be considered. Make sure to list FNU's federal school code, 017069, in Step Six of the form. You are strongly encouraged to complete a FAFSA online, at least two weeks before the deadline.

If you already filed a FAFSA with FNU for the 2020-2021 or 2021-2022 award year, or are a graduate, international or transient student, no FAFSA is required. You must still complete the Grant Election Form to be considered for a grant.

<sup>&</sup>lt;sup>1</sup> Note: An initial version of this communication (and the related election form) included a voluntary option for students to request the University to apply their grant funds directly to their outstanding account balance. The University learned this option may have caused confusion among students. To ensure that all students have maximum flexibility in use of the Emergency Grant funds, FNU determined it would be most appropriate to issue funds directly to all recipient students. Students were notified of this update and given an option to retract their overall grant election accordingly.

For part time students, the "cost of attendance" includes tuition and fees, room and board, books and supplies, transportation, and dependent care.
- These may be expenses you have already incurred or expenses you will incur in the future.
   However, you may not use this money to satisfy any expenses already covered by any
   Emergency Grant funds you previously received from FNU.
- If you do not expect to use all of the Emergency Grant funds for these expenses, please contact the Financial Aid Office by May 31, 2022 to return any excess funds.
